Great Thatch Island

Saving a National Treasure for the British Virgin Islands



Great Thatch Island is one of the most culturally, historically, and ecologically significant landscapes in the Caribbean. This project will restore it as a flagship destination for heritage, biodiversity, and sustainable tourism—creating jobs and revenues for the British Virgin Islands while preserving and celebrating national identity.

The BVI National Parks Trust will oversee all management, development, and operations to ensure conservation standards are maintained, ownership is transparent, and governance is consistent.

• Develop controlled, sustainable access with eco-sensitive infrastructure, overseen by the National Parks Trust of the Virgin Islands.

This is a once-in-a-generation UNESCO World Heritage Site opportunity for the BVI to lead the Caribbean in linking heritage, biodiversity, and sustainable tourism.

Suggested Implementation Timeline (2026–2030)

Income & Benefits for the BVI

Appropriate overheads, running costs, visitor fees and support mechanisms will be built in so that the site generates a sustainable surplus, a top priority during the development stage.


- Controlled visitor numbers projected to generate \$2M annually by Year 5, strengthening long-term government revenues.
- Creation of skilled jobs in heritage conservation, ecological monitoring, guiding, hospitality, and cultural enterprise.
- Education and training programmes embedded for schools, young people, and local entrepreneurs.
- International visibility for the BVI as a Caribbean leader in regenerative tourism and cultural heritage.
